WHEREAS, the Board of Trustees of Global Leadership Academy Charter School recognizes the following statistics²:

- In the United States, there have been 119 school shootings in which at least one person was killed or injured since 2018;
- There have been 26 school shootings reported in the U.S. so far this year

WHEREAS, the Board of Trustees of Global Leadership Academy Charter School recognizes that preserving the basic health safety and welfare of Global Leadership Academy Charter School scholars, parents, teachers and administrators is a priority that supersedes and is a condition precedent to the delivery of education;

WHEREAS, the Board of Trustees of Global Leadership Academy Charter School grieves for recent senseless loss of life involving the 19 children and 2 teachers murdered in Ulvade Texas on May 24, 2022 and is uniformly compelled to take all proactive measures to prevent a similar occurrence at Global Leadership Academy Charter School;

RESOLVED, the Board of Trustees of Global Leadership Academy Charter School hereby authorizes the Chief Executive Officer to develop strategies, processes and procedures, as well as take all other action to the extent allowed by law that is deemed necessary, in the sole discretion of the Chief Executive Officer, to protect the school community, including its students, staff, volunteers, and other stakeholders.

FURTHER RESOLVED, the Board of Trustees of Global Leadership Academy Charter School formally directs the Chief Executive Officer to make school safety from gun violence, especially where any member of our community is facing the risk of imminent bodily harm through threat or action, the absolute and highest priority and pre-requisite to any other activity engaged in by Global Leadership Academy Charter School.
