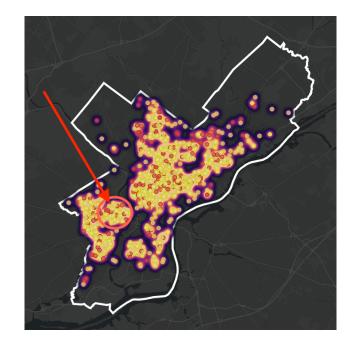

WHEREAS, the Board of Trustees of Global Leadership Academy Charter School Southwest at Huey recognizes the growing Gun Violence Crisis in Philadelphia, as it is characterized by the Philadelphia City Controller below and annotated with a circle depicting the geographical region where the school and many of the school's families are situated:



WHEREAS, the Board of Trustees of Global Leadership Academy Charter School Southwest at Huey recognizes the following statistics:

- In the United States, there have been 119 school shootings in which at least one person was killed or injured since 2018;
- There have been 26 school shootings reported in the U.S. so far this year

WHEREAS, the Board of Trustees of Global Leadership Academy Charter School Southwest at Huey recognizes that preserving the basic health safety and welfare of Global Leadership Academy Charter School Southwest at Huey scholars, parents, teachers and administrators is a priority that supersedes and is a condition precedent to the delivery of education;

WHEREAS, the Board of Trustees of Global Leadership Academy Charter School Southwest at Huey grieves for recent senseless loss of life involving the 19 children and 2 teachers murdered in Ulvade Texas on May 24, 2022 and is uniformly compelled to take all proactive measures to prevent a similar occurrence at Global Leadership Academy Charter School Southwest at Huey;
